What is the Hate Incident Support Service?

The Hate Incident Support Service is managed by the charity Victim Support in partnership with the West Sussex Harm Reduction Team. We give free and confidential one-to-one support to people who have experienced:

- racism
- religious hatred
- homophobia
- transphobia
- disability discrimination.

We can give you both emotional support and practical help and advice both immediately after an incident or later.

How we canhelp:

The type of support we can give you includes:

- help with any questions you have in relation to the incident or what your options are
- someone to talk to in confidence about what has happened (we can arrange interpreters if necessary)
- giving you information about the police and court procedures

- helping you to deal with other organisations in relation to the incident
- support at court if you are called as a witness
- putting you in touch with other practical sources of help
- helping parents to support children effectively if they are affected by the incident

What happens when you contact the service?

Victims, witnesses or anyone else can report a hate incident. You can get in touch with us either by filling in a hate incident reporting form (see over) or by calling our victim care team on 0845 38 99 528.

The service has two main aims:

- to give you a way to report incidents confidentially
- to help you get support if you need it.

If you send us a hate incident reporting form and say you want us to contact you, our dedicated caseworker or one of our team of trained volunteer support workers will contact you to discuss the help you need and to organise support.

If you choose to call our victim care team, they will take details of the incident and discuss what support, if any, we can give you.

Either way, we won't give your personal details to anyone else without asking you first.

A few words of advice

If you're experiencing hate incidents try not to put yourself at greater risk. If you come into contact with the person responsible, try to get away safely or go to a more public place. If you can, keep a record of all incidents including dates and times. Remember that nobody deserves to suffer just because of who they are and help is available.
