



You have previously been sent an update inviting you to make comments on Crawley's submission Local Plan, the Local Plan Map and the Sustainability Appraisal. We are now writing to you as a reminder of the date for the closing of this formal stage of public consultation. The six-week consultation period started on 1 September and will end at **5pm on 13 October 2014**. Any comments submitted after this date will not be accepted.

#### Previous comments on the Local Plan

Responses that were received during previous stages of consultation were considered by the council and have helped to shape the current submission Local Plan (2014). Comments received through earlier consultations on the Local Plan are set out in the Crawley Local Plan Consultation Statement. However, these will not be considered as formal representations on the submission Local Plan by the Planning Inspector as part of the examination process. If you submitted a response at a previous stage of consultation and would like this to be considered by the Inspector then you must re-submit your comments by 5pm on 13 October using the council's submission Local Plan representation form as set out below.

#### Next steps: Examination and hearings held in public

After the consultation period ends on 13 October, the Local Plan and all of the representations received will be submitted to the Secretary of State. A Planning Inspector will then be appointed to carry out a public examination on the Local Plan and its evidence base. The Planning Inspector will hold a series of public examination hearings, which will take place at the Town Hall. The subject of the examination hearings is determined by the Planning Inspector and will be based on the documents submitted by Crawley Borough Council and the representations made.

If your representation is seeking a modification to the Local Plan or part of the plan and you would like to participate in the public examination hearings, then you must state this in your representation. The hearings are open for anyone to observe, but participation in the discussion is only by invitation from the Inspector to those who have outstanding concerns which relate to matters being discussed at the hearing sessions.

The programme officer will, on behalf of the Inspector, circulate the timetable for the Local Plan examination hearing sessions and will inform those people who are invited to attend a hearing session.

## Crawley Submission Local Plan consultation notes and representation guidance Please use these notes to help you complete your comments.

## Introduction

Formal comments supporting or objecting to the Local Plan can be made before it is submitted to the Secretary of State for independent examination by a planning inspector. The purpose of the examination is to consider whether the Local plan complies with legal requirements, the duty to co-operate and is sound. In order for your comments to be considered by the planning inspector alongside the submitted plan, all comments must adhere to the guidelines outlined in this document.

#### Legal compliance and duty to co-operate

The Inspector will first check that the plan meets the legal requirements and the duty to co-operate before moving on to test for soundness.

You should consider the following before making a comment on legal compliance:

- The plan should be included in the current <u>Local Development</u> <u>Scheme (LDS)</u> and the key stages should have been followed. The LDS is a programme of work prepared by Crawley Borough Council, which sets out details of the Local Development Documents (LDDs) that the council intends to produce, and outlines the key stages and timetable involved in producing each document. The LDS is on the council's website and available at the Town Hall.
- The process of community involvement should be in accordance with the council's <u>Statement of Community Involvement (SCI)</u>. The SCI sets out the council's strategy for involving the community in the preparation and revision of LDDs (including plans) and the consideration of planning applications.
- The plan should comply with the <u>Town and Country Planning (Local Planning) (England) Regulations 2012</u>. This requires that upon publication of the Local Plan, the council must publish the necessary documents and make them available to view at the Town Hall and on its website. The council must also inform the Local Plan bodies and anyone who has asked to be notified.
- The council is required to provide a <u>Sustainability Appraisal Report</u> when it publishes its plan. This should identify how the Sustainability Appraisal has been carried out, the baseline information used to inform the process and the outcomes. The Sustainability Appraisal helps to assess policies to ensure they reflect social, environmental and economic factors.
- The plan must consider any <u>Sustainable Community Strategy</u> (SCS) for its area (i.e. county and district). The SCS is usually prepared by the Local Strategic Partnership, which is representative of a range of interests in the council's area. The SCS is subject to consultation but not to an independent examination.

- The Local Plan must comply with the Duty to Cooperate. This is a legal duty requiring local planning authorities, county councils and public bodies to engage constructively and actively on an ongoing basis to take account of cross-boundary issues. You should consider the following before making comments on compliance with the duty to co-operate:
  - Councils will be expected to provide <u>evidence</u> of how they have complied with the duty to co-operate.
  - Non-compliance with the duty to co-operate cannot be rectified after the submission of the plan. The Inspector has no power to recommend modifications. Where the duty has not been complied with, the Inspector has no choice but to recommend non-adoption of the plan.

## Soundness

The Inspector has to be satisfied that the plan is positively prepared, justified, effective and consistent with national policy.

- Positively prepared This means that the plan seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development.
- Justified The plan should be the most appropriate strategy when considered against reasonable alternatives, based on proportionate evidence.
- Effective The plan should be deliverable over the plan period and based on effective joint working on cross-boundary strategic priorities.
- Consistent with national policy The plan should enable the delivery of sustainable development in accordance with the National Planning Policy Framework.
- If you think the content of the plan is not sound because it does not include a policy where it should do, you should go through the following steps before making comments:
  - Is the issue already covered specifically by national planning policy? If so it does not need to be included.
  - Is this issue covered by any other policies in the plan or in any other plan?
  - If the policy is not covered elsewhere, in what way is the plan unsound?
  - □ If the plan is unsound without the policy, what should the policy say?

#### **General advice**

If you wish to make a comment which is seeking a modification to the plan or part of the plan you should make clear in what way it is not sound with regard to the legal compliance, the duty to cooperate and the four requirements set out above. You should try to support your comments with evidence showing why the plan should be modified. It will be helpful if you could also say precisely how you think the plan should be modified by suggesting an alternative.

There will not normally be a subsequent opportunity to make further submissions, so any comments or modifications should be made clear and cover all of the evidence and supporting information that is necessary. After this stage, further submissions will only be at the request of the Inspector, based on the matters and issues s/he identifies for discussion at the examination.

Where there are groups who share a common view on how they wish to see the plan modified, it would be very helpful for that group to send a single set of comments which represents their view, rather than for a large number of individuals to send in separate comments which repeat the same points. In such cases the group should indicate how many people it is representing and how the comments have been authorised.

# **Questions to Consider....**

If you think the content of the Local Plan is not sound because it does not include a policy where it should do, you should go through the following steps before making a comment:

- Is this issue already covered specifically by national planning policy?
- Is the issue covered by any other policies in the Local Plan or in any other plan?
- If the policy is not covered elsewhere, in what way is the plan unsound?
- If the plan is unsound without the policy, what should the policy say?



# Legal Compliance

You should consider the following before making a comment on legal compliance:

- The Local Plan should be included in the current Local Development Scheme (LDS) and the key stages should have been followed. The LDS outlines the key stages and timetable involved in producing each document.
- The process of community involvement should be in line with the council's Statement of Community Involvement (SCI). The SCI sets out the council's strategy for involving the community in the preparation of development plan documents.
- The Local Plan should comply with the Town and Country Planning (Local Planning) (England) Regulations 2012.
- The council is required to provide a Sustainability Appraisal. The Sustainability Appraisal helps to assess policies to ensure they reflect social, environmental and economic factors.
- The plan must consider any Sustainable Community Strategy (SCS) for its area.



# The Duty to Cooperate

You should consider the following before making a comment on the Duty to Cooperate:

- The Duty to Cooperate requires local planning authorities, county council and public bodies to engage constructively and actively on an ongoing basis to take account of cross boundary issues.
- Councils must provide evidence of how they have complied with the Duty to Cooperate.
- Non-compliance with the Duty to Cooperate cannot be rectified after the submission of the Local Plan.
- If the Duty to Cooperate has not been complied with, the Planning Inspector has no choice but to recommend non-adoption of the Local Plan.



# Soundness

You should consider the following before making a comment on Soundness:

The Planning Inspector has to be satisfied that the plan is positively prepared, justified, effective and consistent with national policy.

- Positively Prepared- The Local Plan should seek to meet objectively assessed development and Infrastructure requirements, including unmet needs from neighbouring authorities. It should also be consistent with achieving sustainable development.
- Justified- The Local Plan should be the most appropriate strategy when considered against reasonable alternatives.
- Effective- The Local Plan should be deliverable over the plan period and based on effective joint working on cross boundary strategic priorities.
- Consistent with national policy- The plan should enable the delivery of sustainable development in accordance with the National Planning Policy Framework.



# Next Steps.....

1. Submission

Once the 6 week consultation has finished on 13 October 2014. The published plan and all of the representations made will be submitted to the Secretary of State who will appoint a Planning Inspector.

The Planning Inspector will:

- Consider all of the representations made.
- Carry out an examination on the Local Plan and its evidence base through a series of public examination hearings.
- Lead the examination and determine the matters for discussion at the public examination hearings.



- 2. The Public Examination Hearings
- If your representation is seeking a modification to the Local Plan or part of the plan and you would like to participate in the public examination hearings then you must state this in your representation.
- The Planning Inspector will assess the Local Plan through a series of public examination hearings to determine whether it has been prepared in line with the duty to cooperate, legal requirements and is sound.
- The subject of the examination is determined by the Planning Inspector based on the documents submitted by the Local Planning Authority and the representations received.
- The Planning Inspector may invite those who have requested to appear at the hearings to engage in a debate over a specific topic area, however participants must demonstrate why the plan is unsound with reference to evidence.
